Sealcoating: A morion was made by Gavin Styer and seconded by Curt Heit to approve Scott's Construction Co. to sealcoat Decker Road for \$77,261.00. Motion carried.

ARPA Funds: A motion was made by Curt Heit and seconded by Gavin Styer for the clerk to transfer the balance of the ARPA funds account to the regular checking account to help pay Universal for the truck equipment. Motion carried.

Vouchers: Curt Heit moved and Gavin Styer seconded to pay the vouchers presented. Motion carried.
