

The regular monthly meeting of the Town of Weston Board was held on Tuesday, March 12, 2024 at the Town of Weston Hall. Present were Bruce Podoll, Curt Heit, Gavin Styer, Pat Pickerign, and Cindy Wang.

The meeting was called to order at 7:00 p.m. by Chairman Bruce Podoll.

The minutes of the February meeting were read. Curt Heit moved and Gavin Styer seconded to approve the minutes as read. Motion carried. Clerk is to write a check out of the ARPA funds to put in the Town of Weston checking account to pay Chimney Rock Appraisal \$32,000.00 for the re-evaluation.

The treasurer's reports for January and February were read. A motion was made by Curt Heit and seconded by Gavin Styer to accept the January and February reports as read. Motion carried.

There were no public comments or meeting reports.

DISCUSSION & ACTION ITEMS:

Roadwork: The new tires were put on the tractor. Jody Anderson has been brushing and plowing and sanding roads as needed.

Broadband clean up: Todd Sisko said the clean up in areas where the broadband cables had been laid can't be cleaned up until the company comes back into the area. Jody Anderson will locate the spots that need to be cleaned up.

Truck update: Nothing new on the truck.

Ag Road Improvement Grant: The state will help fix up roads being used by farmers, loggers, cheese plant haulers, etc. If grant money is used to fix up these roads, weight restriction bans can not be placed on these roads.

Roads that would qualify would be: Dunkard Road, but there is not much ag use on that road; 290th Street from Randy Styer's south to past Dale Styer's or Eau Galle line; 350th Avenue from County Road D west to County Road P (past Bruce Podoll's).

It was suggested to have an engineer come to a meeting. Bruce Podoll will check to see if Ayres & Associates have submitted any requests.

Patrolman Review: Chairman Podoll stated they had talked to Jody Anderson About a raise, It was decided to give Jody a \$.50 raise starting April 1, 2024.

Annual meeting: Curt Heit moved and Gavin Styer seconded to set the annual meeting for 7:00 p.m. on April 16, 2024 with the regular monthly board meeting to follow immediately Motion carried.

Board of Review: Curt Heit moved and Gavin Styer seconded to set first meeting of the Board of Review for Tuesday, May 14, 2024 at 6:30 p.m. which will be adjourned until a later date when the revaluation will be completed. The regular monthly board will be held immediately following the adjournment of the Board of Review meeting. Motion carried.

Curt Heit moved and Gavin Styer seconded to approve paying vouchers presented. Motion carried.

Gavin Styer moved and Curt Heit seconded to adjourn the meeting. Motion carried. Meeting adjourned at 7:30 p.m.
