**Roadwork:** Jody Anderson reported that he has been mowing, grading a few roads, put rock on some roads. The patching is all done. Someone has been stealing road signs by Craig Lecheler and Husby's. The 2015 Mack Truck was sold for \$110,000.00 to a town by Barrabo.. Three batteries were purchased for the truck

**Bridge report:** Three of the four bridges in the town were in good condition. The Wedam bridge on 470<sup>th</sup> Ave. over Irving Creek is in need of major repair or be replaced. To replace the bridge would cost approximately \$650,000.

**LRIP report:** The clerk is to call Issac Steinmeyer to see what is needed to fill out report for LRIP funds. This would be for black top only.

**Fire Department update:** Gavin Styer moved and Bruce Podoll seconded to sign the mutual agreement with the Menomonie Fire Department. Motion carried.
