The meeting was called to order at 7:00 p.m. by Chairman Bruce Podoll.

The minutes of the April meetings were read. A motion was made by Craig Lecheler and seconded by Bruce Podoll to approve the minutes as read. Motion carried.

The treasurer's report was read. Craig Lecheler moved and Bruce Podoll seconded to accept the treasurer's report as given. Motion carried.

MEETING REPORTS: Bruce Podoll attended the meeting of the Elmwood Fire Department. The fire department would like to sell one of their trucks and purchase a new truck with a pumper.

DISCUSSION & ACTION ITEMS:

ROADWORK: Jody Anderson has been cutting brush, grading and patch roads.

TOWN TRUCK UPDATE: Bruce had the approximate prices for a new truck as follows:

Peterbilt: \$141,370.00 without latest price raise.

Freightliner: \$140,000.00

River State Western Star: \$150,000.00

I State Truck Center Western Star – Marshfield: \$136,000.00

It is recommended the town sell the old truck on its own.

The following are to be deleted: \$1,575.00 for 5 year extended towing and \$485.00 for electrical wiring. This would bring the approximate cost to \$134,500.00.

A motion was made by Craig Lecheler and seconded by Bruce Podoll to pay \$10,000.00 to I State Truck Center to order a Western Star Truck. Motion carried.

UNIVERSAL: Craig Lecheler moved to pay Universal \$5,000.00 to order equipment for the new truck. Bruce Podoll seconded. Motion carried. The equipment includes stainless steel box, sander, plow, wings, and a bigger tool box.

LAWN MOWING: Craig Lecheler moved and Bruce Podoll seconded to pay Dennis Ziehme \$35.00 per mowing for mowing the town shop/hall lawn. Motion Carried.

TOWN WEBSITE: The homepage for the town website would include description, agenda, meeting minutes, election notices. Other information can be added later. Domain registration-Town Of Weston-WI.com. The cost would be

\$1,115.00 plus \$600.00 to add .gov site e-mail. Craig Lecheler moved to pay Josh Meyer \$345.00 to start setting up the town website.

BIPARTISAN INFRASTRUCTURE BILL (BIL): Bruce Podoll is trying to contract someone in Eau Claire about writing a grant.

DOG LICENSE AMENDMENT: Craig Lecheler moved and Bruce Podoll seconded to amend the dog license fees that were set at the April meeting to the following: \$5.00 for spayed/neutered, \$10.00 for male/female, and \$40.00 for a kennel license. Motion carried.

DRIVEWAY PERMIT: Craig Lecheler moved and Bruce Podoll seconded to approve a driveway permit for a field driveway for Gregg Anderson with the specification that a 18 inch X 40 foot culvert with an apron and end walls be installed. Motion carried.

VOUCHERS: Craig Lecheler moved to pay the vouchers presented. Bruce Podoll seconded. Motion carried.

ADJOURN: Bruce Podoll moved and Craig Lecheler seconded to adjourn the Meeting. Motion carried. Meeting adjourned at 7:55 p.m.
